The free economic zones (FEZs) of the Republic of Moldova are part of an exceptional project, unique for the Europe and Asia, either by the amount of tax and customs preferences or by the level of state guarantees provided for residents. At present, the Republic of Moldova has 7 FEZs, located all over the country regions, and an international free port and airport, which are similar to free economic zones.

The economic zones, stimulating industrial production and export, offer investors an exceptional opportunity to reduce investment risks, ensure the manufacture of competitive production, and ensure access to the EU and CIS markets.

It should be mentioned that the managing bodies of the free economic zones are reliable partners to the residents. They contribute to the utmost to the development of a favorable investment climate, help foreign investors to adapt to the new country, and are, also, efficient champions for the legal interests of the entrepreneurs. Moldova's free economic zones are waiting for its investors.

RESULTS OF FEZ ACTIVITY IN 2010

159 residents **have been registered** in 7 free economic zones. **As of 1 January 2011 the number of employees reached** 5,177 persons, which is 1.7 times higher compared to the end of 2009.

The investment amount throughout the period of FEZs activity exceeded 128 million USD, 12.3 million USD of which being invested in 2010.

The total amount of goods and services sale is 1.7 billion MDL, of which 80% are from industrial production. The total amount of sales of industrial production within the reporting year increased with 43.3% compared to the same period of the last year, and represented 5.2% of the industrial production volume manufactured by the industrial enterprises of the Republic of Moldova.

About 80% of the industrial production was exported.

Basic industrial goods are: grape wine, divin (cognac), electrical wiring for cars, synthetic covers for car seats, light industry goods, cork products, electronics and gas burners, furniture, carpets, PET preforms, polymer film, heating oil.
